<b>Care Assist Grants</b>	
<b>Respite</b>	
<p style="text-align: center;"><b>Acceptable</b></p> <ul style="list-style-type: none"> <li>Professional private duty home care</li> <li>Patient caregiving by anyone not living in home</li> <li>Lawn and yard care</li> <li>House cleaning or domestic services</li> </ul>	<p style="text-align: center;"><b>Not Acceptable</b></p> <ul style="list-style-type: none"> <li>Residential living - room and board fees</li> <li>Caregiving by someone living in home</li> </ul>
<b>Medical Expenses</b>	
<p style="text-align: center;"><b>Acceptable</b></p> <ul style="list-style-type: none"> <li>Prescribed medications for ALS symptoms/diagnosis</li> <li>Clinic fees/co-payments for ALS related appointments</li> <li>Feeding/PEG tube procedure, supplies/equipment, and prescribed formula</li> <li>Portable generators</li> <li>Insurance copays for durable medical equipment</li> <li>Private pay acupuncture/massage therapy/aquatic therapy</li> </ul>	<p style="text-align: center;"><b>Not Acceptable</b></p> <ul style="list-style-type: none"> <li>Any prescription medications not related to ALS</li> <li>Health insurance premiums</li> <li>Utility bills</li> <li>Doctor/hospital fees or copays not related to ALS</li> <li>Pool fees or equipment</li> <li>Any type clothing, groceries, toiletries, shoes, sheets, blankets, pillows</li> <li>Vitamins or dietary/nutritional supplements</li> <li>Recommended medical marijuana and/or CBD oil</li> </ul>
<b>Home Modifications</b>	
<p style="text-align: center;"><b>Acceptable</b></p> <ul style="list-style-type: none"> <li>Building of ramps (material &amp; labor)</li> <li>Home accessibility (material &amp; labor)               <ul style="list-style-type: none"> <li>For example: Bathroom modifications, kitchen modifications, widening doorways, replacing flooring, installation of lift/elevator to home, etc.</li> </ul> </li> </ul>	<p style="text-align: center;"><b>Not Acceptable</b></p> <ul style="list-style-type: none"> <li>Interior or exterior painting, unless area affected by approved renovations</li> </ul>
<b>Vehicle Modifications</b>	
<p style="text-align: center;"><b>Acceptable</b></p> <ul style="list-style-type: none"> <li>Purchase or repair of accessible vehicle</li> <li>Vehicle modifications intended to aid those living with ALS (e.g. installation of wheelchair ramp, installation of hitch for wheelchair or scooter, etc.)</li> </ul>	<p style="text-align: center;"><b>Not Acceptable</b></p> <ul style="list-style-type: none"> <li>Mileage</li> <li>Automobile purchase, repair, or maintenance for non-accessible vehicle</li> </ul>
<b>Activities of Daily Living (ADL) Grant</b>	
<b>Communication/Equipment</b>	
<p style="text-align: center;"><b>Acceptable</b></p> <ul style="list-style-type: none"> <li>Durable equipment and devices (including bathroom medical equipment)</li> <li>Portable ramps</li> <li>AFO braces/splints</li> <li>Tablet device for communication</li> <li>Computer software or apps for communication</li> <li>Augmentative communication &amp; alert devices</li> <li>Adaptive switches and access methods for tablets or computers</li> <li>Emergency call system rentals or purchases</li> </ul>	<p style="text-align: center;"><b>Not Acceptable</b></p> <ul style="list-style-type: none"> <li>Computer repairs</li> <li>Internet fees or phone bills</li> <li>Televisions/apple TV</li> <li>Virus protectors</li> <li>Computer tables/desks, device covers, screen protectors, or any type of device accessories</li> </ul>
